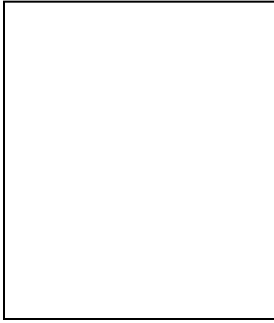
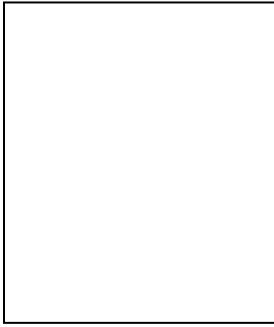

**STATEMENT**

To complete our application for film/video/documentary shooting permit in Indonesia, I/we hereby declare that I/we shall:

1. Observe all regulations of the Government of the Republic of Indonesia (both Central and Provincial Government);
2. Report on our arrival to the Ministry of Education and Culture c.q. Film Development Center to obtain details of central and local rules before filming begins;
3. Report to the Information Services of the Provinces/Regional Government that will appoint a liaison officer, and bear all expenses related to the services, or appointed by Film Development Center;
4. Have a local partner/fixer which obtained registration by Film Development Center;
5. Conduct Shooting in accordance with the approved script/synopsis and object/locations as set out in the shooting permit issued by the Ministry of Education and Culture;
6. Not film strategic/vital objects/and locations;
7. Bear all expenses towards taking objects/locations which have specific rules and if deemed necessary, additional expenses will also be borne;
8. Re-export all our shooting equipments at our own expense upon completion of filming and bear all related costs on CBP/ATA Carnet
9. Should declare if using unmanned aircraft system / drone to the Directorate General of Civil Aviation.
10. Submit 1 (one) released copy of film/video to the Ministry of Education and Culture c.q. Film Development Center through the Embassy of the Republic of Indonesia/Consulate General of the Republic of Indonesia which may be used of the discretion of the Government of the Republic of Indonesia for non-commercial purposes.
