EMBASSY REFURBISHMENT PROJECT 2019 - EXPRESSION OF INTEREST

QUALIFYING CRITERIA CHECKLIST

During 2019, *The Embassy of the Republic of Indonesia* intends to extensively refurbish our existing London Embassy building at 30 Great Peter Street, SW1P 2BU.

Context and Brief - The Embassy and staff will remain in-situ and operational during a phased works programme, which will likely incorporate a significant Building Services installation, re-design and refit of four upper-floors and extensive re-modelling of the entrance lobby areas (including the designing and forming of a double-height space, with installation of a new linking steel staircase). A full professional team are already in place and appointed.

We therefore and hereby invite Expressions of Interest from;

Turnkey Design & Build contractors, with a particular focus on London fitout.

To qualify for consideration, you must be able to demonstrate certain Qualifying Criteria – below are the <u>minimum requirements</u> that will need to be demonstrated in order for you to be considered for advancement to the next stage:

a track-record and testimonials covering the above criteria, with at least three detailed Case Studies for recent projects, i.e. projects which comprised breaking-through concrete slab, staircase design & installation and in-situ working

Note – furniture supply is not within scope of this project, but we require financial data of any Furniture Divisions to be separately identified
